We have continued to keep in mind the Charity Commission's guidance on public benefit and focussed our activities in providing money to enable the school to continue its work helping all children regardless of ability. By paying the salaries of specialist teachers and offering vocational courses at the school we are enabling the children to reach goals that would not otherwise be available to them.

The Charity continues to be supported by volunteers in the form of friends and family who have assisted the Trustees to prepare and enable our fund raising events to take place.

This year one volunteer has been to the school. She is a qualified teacher who is intending to study for her MA in African Studies. Her knowledge and experience have greatly benefitted the children at the school.

**Summary of the main achievements of the charity during the year**

This year our income totalled £17,446.86. This figure included the sum received from our Charities Gift Aid reclaim for 2009/2010 but our reclaim for the current year of £2172.80 will go into the figures for next year.

- 1) The money shown in our figures for this year has been raised from the following:
  - a) Specific generous one-off donations from individual supporters and organisations
  - b) Regular donations to general funds
  - c) Regular donations to sponsor individual children
  - d) Sponsored events where ALC has been named as the beneficiary:
    - i) Petanque competition - £130
    - ii) Sponsored walk - £107.59
    - iii) Plant sales - £140
    - iv) Wedding donation - £1,255
    - v) Golf competition - £201
  - e) Selling donated goods at boot fairs - £831.04
  - f) Annual quiz evening - £657.02
  - g) Monies raised through talks - £700
  - h) Sale of goods designed and hand made by one of the Trustees - £1,581.75
- 2) We have also received the following donations:
  - a) Further books from a charity supplying books directly to the school
- 3) With the income we have, amongst other things:
  - a) Continued to pay salaries of specialist teachers, occupational therapist and librarian
  - b) Transferred money for specific pupils from individual sponsors
  - c) Completed the dormitory building for the youngest children
  - d) Continued with the water conservation projects
  - e) Built toilets
  - f) Bought additional food supplementing supplies due to spiralling costs
  - g) Bought physiotherapy equipment
  - h) Furnished the dormitory building
  - i) Purchased further equipment for the library
  - j) National Curriculum books
  - k) Tiled boys' dormitory
